## When will the change of status take effect?

The change of status will occur on the date that this form is received by the ASAR secretariat. Medicare Australia will be notified of your change of status. The ASAR secretariat will provide you with written confirmation of your change of status and your CPD obligations.

**Change of status cannot be backdated therefore please inform the Secretariat promptly.**

## Are there any fees involved?

There is no fee charged to change from student status to accredited sonographer status. However, if there is a renewal fee payable when upgrading your status and an invoice has been sent to you, you can attach the renewal payment with this form.

## What documents do I need to submit to change my status?

A copy of the certificate or testamur (certified by a Justice of the Peace) or a verification letter from the institution where you undertook the accredited program that states that you have successfully completed the program needs to be attached with this form.

**If you are NOT A PERMANENT RESIDENT and have graduated with an ASAR accredited post graduated qualification in ultrasound, then you must follow the application process for overseas applicants (AIR assessment) as outlined for temporary residents/overseas qualifications. If you do not provide AIR certificate, your status cannot be changed.**

## What are my CPD obligations?

In order to remain on the Register as an accredited sonographer, you must fulfill the Continuing Professional Development (CPD) requirements of the Registry. A minimum of 40 CPD credits must be acquired in each triennium. More information about the CPD requirements is given on Page 4. After reading Page 4, you will need to complete Page 5 and send with this form.

## ASAR CPD Requirements

**This section contains information about the CPD requirements of ASAR. After reading the information below, applicants will have to complete the CPD Nomination Form on the next page.**

All Sonographers will have to nominate an ASAR recognised CPD program that will be used to satisfy their accreditation CPD requirements for that year. Once a CPD program is selected the accredited sonographer will be required to meet the CPD requirements of that program. Changing to an alternative CPD program is permitted at the beginning of each year when renewing the ASAR membership. This is the only time when a sonographer will be able to transfer or opt out of their nominated CPD program.

In addition, regardless of the program selected, the individual must ensure they comply with their nominated CPD program requirements over 3 years, taking into account their ASAR triennium date.

All sonographers will be tracked by ASAR using existing triennium dates. All educational providers will send a CPD report of each individual to ASAR at the end of their ASAR triennium to ensure that all members are complying with their nominated CPD program requirements.

Managers of each CPD program conduct audits; therefore all CPD documentation must be kept and made available for audit if requested.

### **ASAR currently recognises 4 CPD programs:**

- the Maintenance Of Standards In Professional Practice (MOSIPP) program conducted by the Australian Society for Ultrasound in Medicine (ASUM)
- the AIR CPD program conducted by the Australian Institute of Radiography (AIR)
- the ASAR CPD program
- the PD-asa CPD Program conducted by the Australian Sonographers Association (ASA)
